JULIE GOLDSMITH, CHAIR

Julie became a Trustee in 2017 and was elected Chair of The Arts Society in May 2018. During a successful career in Publishing, Julie was Senior Vice President of Egmont, and CEO of its UK publishing companies. In 2003 she was appointed M.D of the publishing division of the Royal Horticultural Society.
